Medical/Liability Release

All participants must have a signed release form. Your child's participation is voluntary. Your written consent at the bottom of this form is required for your child to participate. I acknowledge there are inherent risks of physical injury or illness to Camp Bighorn participants and I agree to assume the full risk of any injuries, damages or loss, associated with my child's participation in this program. I waive and relinquish any and all claims for injuries, damages, or loss of any kind that my child, I, my insurer, or my estate may have against the Camp Bighorn Program, the National Bighorn Sheep Center, and their officers, agents, servants, volunteer instructors and employees ("Released Parties") which I may have or which may accrue to me on account of my child's participation in the above program. I consent for my child to receive first aid and other emergency medical treatment in the event of an injury or illness incurred during his/her participation in the Camp Bighorn Program, and I waive and relinquish any and all claims for injuries, damages, or loss that my child, I, my insurer, or my estate may have against the Released Parties arising out of such treatment. I give permission for the Released Parties to seek emergency medical services for my child should he/she become injured or ill during his/her participation in the program with the understanding that I am responsible for any expenses incurred. I understand that the Released Parties do NOT provide any medical insurance coverage for my child while participating in this program.

If your child fails to abide by any rules of conduct and instructions during the activity, it may become necessary to discontinue his/her participation in the activity. By participating in Camp Bighorn, it is further understood and agreed upon that your child will abide by the general rules and conduct prescribed for guests of the Whiskey Mountain Conservation Camp and that violations may result in a denial of privileges, a forfeiture of all fees paid and immediate removal from the Whiskey Mountain Conservation Camp property.
